The Tony Young All-Star Karate Academy is a privately owned and operated Martial Arts School by World Champion Anthony (Tony) Young. Master Young's training and experience consist of 31 years. He is a 7th Degree Black Belt and has held the title of United States National Super-Light Weight Karate Champion for 19 consecutive years and has garnered over 1000 championship awards and prizes. Master Young has been inducted into many prestigious Karate Halls of Fame. The Tony Young All-Star Karate Academy has been in existence for 24 years teaching children, young adults, adults, seniors, and children and adults with learning and developmental disabilities, physical limitations and medical problems.

The program which will be offered to the Pre-School of the Holy Spirit Preparatory School will be a 45-minute Karate class: PreK-3 12:30PM – 1:15PM; PreK-4 1:00PM – 1:45 P.M., which will consist of the basic fundamentals of Karate – Warm-Up (Exercises); Stances; Punches; and Kicks. The age group is for 3 and 4 year olds who will be required to wear a White Karate Uniform and a Blue Karate T-Shirt to each class. Students will have lunch from 12:00N until 12:30 P.M. for PreK-3; and 12:30 P.M. – 1:00 P.M. for PreK-4, that parents will be responsible for providing.
